# In the Context of International Crisis, Solidarity is More Relevant than Ever'

During the recent Luncheon of the College of Experts, on 26 September last, the floor was given to Bénédicte Menanteau, Executive Director of Admical and to Jean-Louis Vielajus, Executive Director of CFSI. Paths for reflection emerged for NGOs and Donors. Objectives:

To work together ever more closely and for the duration ...

In the preoccupying context of the international crisis we are experiencing, Gérard Brémond, President of the Ensemble Foundation, arranged these encounters, reiterating his determination to stay the course. We can be worried about developments, especially for the poorest populations. The actions of the Foundation are now more necessary than ever. I want to make sure that these actions are preserved.' Then, with Jacqueline Délia Brémond, Vice-President, the Founders warmly thanked each Member of the Board of Directors for their involvement alongside the Foundation. They also noted the faithful commitment of the College of Experts in the selection and monitoring of the projects supported. We are happy to be able to build on their skills and their good will'.

This year, two members of the Jury of the Ensemble Foundation's Competition were also present: Bénédicte Menanteau of Admical and Cécile Ostria, Managing Director and Spokesperson of the Foundation for Nature and Man.

'This day is important' — noted J. Délia Brémond - 'because the Board of Directors of the Foundation will also meet to choose the winner of the Grand Prize of the Ensemble Foundation', (see box).

J. Délia Brémond continued her presentation by giving some key figures on the activities of the Foundation, referring to the 160 Programs and Small Grants supported since its inception, in late 2004, and the 18 million Euros invested.

The Vice-President then gave the floor to Olivier Braunsteffer, the new Director of the Foundation, who discussed his career of 18 years in the field of international solidarity and defined his two main challenges. First and foremost 'ensure the continuity of the work accomplished by Irène Serot Almeras, which everyone recognizes as outstanding and through which the Foundation has gained considerable credibility'. In addition, the new Director of the Foundation said that, 'the human and environmental consequences due to climate change, which disproportionately affect the poorest' should also require the utmost vigilance for future commitments.

The floor was then given to two external speakers.

#### Charter of Sponsorship: The Goal of the First 100 Signatories Has Been Exceeded

On the occasion of the 20<sup>th</sup> International Conference of Corporate Sponsorship, organized in Marseilles last May by Admical, (Association for the Development of Industrial and Commercial Sponsorship) the first Charter of Sponsorship was launched. Bénédicte Menanteau, Executive Director, revealed its purposes.

'The premise of the Charter of Sponsorship is the desire to clarify the principles and values of this sector in order to act within a framework of common reference.'

'It is important to remember that this Charter is for all the actors in sponsorship and is intended to be signed by the companies and structures authorized to receive sponsorship', explained B. Menanteau. This is to make available to all 'an educational tool, an ethical reference, to show what sponsorship can bring to companies and to project promoters. Most of the structures involved are still not familiar with sponsorship and its principles'.

The success of the CSR (Corporate Social Responsibility), of the sustainable development at the heart of companies and of sponsorships and partnerships has not been without consequences, creating new sources of confusion, even risks of dilution. 'But it works together. There is no opposition'. And B. Menanteau quoted from the Charter: 'Sponsorship is a free commitment by a company in the service of causes of general interest, signed on for the duration, in the form of a financial donation, products, technology or an infusion of skills without seeking impact on its trading activities'. The company, therefore, cannot expect the same compensation as within the framework of sponsorship. The boundary exists and refers to specific tax provisions that it is important to know. It is all in the right proportion and up until now required clarification'.

Today, the Charter has been signed by more than 100 sponsorship actors: companies - including the biggest - and many large NGOs. This step is, of course, also within the reach of the smallest structures. 'It is important that all, in sharing the principles and the values, operate within a framework of common reference and develop a shared vision'.

This work will be continued in the coming year. Working groups are planned which will feed recommendations on key points identified during the exchanges. The fruit of this work will result in a guide destined to all practitioners of sponsorship. B. Menanteau said, in conclusion, 'I thank the Ensemble Foundation, on whom we can depend to build formidable bridges with the specific world of private foundations.

#### The CFSI in Search of New Partnership Sources to End Starvation

The CFSI (French Committee for International Solidarity) celebrated its 50th Anniversary last year. A total of 24 member organizations mobilized (NGOs, local authorities...) against starvation, poverty and inequality in the world. To mention, among others, the campaign 'Alimenterre' (Feed the Earth).

'We know the figures!' recalled Jean-Louis Vielajus, '900 million under-nourished individuals, directly exposed to price volatility on the international markets. Let us remember the hunger riots of 2008, when the prices of rice and wheat peaked!' To these fluctuations in the global economy, one needs to add the pressure on natural resources and the climate change consequences which weaken yields even more.

Therefore, what solutions can be envisaged? For many years, the CFSI has financed agricultural projects to promote the emergence of sustainable local agriculture. But how do we deploy sufficient resources to live up to these challenges? In 2009, the CFSI and the Foundation of France decided to join a program for the

Promotion of Family Farming in Sub-Saharan Africa, concentrated in 2010 in West Africa. 'We must support efforts to feed the populations of cities, too accustomed to consuming imported goods, with local production which is environmentally friendly.'

With the support of the Ensemble Foundation, (see box), in 2011, this program financed 21 multi-year projects. A Monitoring Committee was set up, with the CFSI taking charge of the management of the call for proposals, the technical and financial monitoring and the process of capitalization. 'Of course, we have to capitalize on all these early experiences, drawing from investigative leads, ways of working together more efficiently.'

No one doubts that, put together, these small initiatives will gain in relevance and impact on a larger scale. In strategic vision and sustainability...
